ONCE ON SCENE I ATTENDED AN INCIDENT BRIEFING GIVEN BY OFFICER SILJANDER #8902. DURING THE BRIEFING I LEARNED THE FOLLOWING.

ROYCE LIVES IN APARTMENT WITH HIS ROOMMATE JAMIL CURD. JAMIL AND ROYCE HAD BEEN USING DRUGS ALL DAY ON 05/20/15. JAMIL AND ROYCE WENT TO SLEEP AROUND 0200 HOURS, ON 05/21/15. JAMIL WOKE UP AROUND 0430 HOURS, AND DID NOT HEAR ROYCE SNORING AND WENT TO CHECK ON HIM. JAMIL WAS UNABLE TO WAKE ROYCE UP AND CALLED 911. I SPOKE WITH JAMIL CURD THE INTERVIEW WAS RECORDED AND UPLOADED ONTO THE SERVER. THE FOLLOWING IS A SUMMARY OF WHAT JAMIL TOLD ME.

ROYCE AND JAMIL HAD BEEN SMOKING METH ALL DAY ON 05/20/15. JAMIL SAID THEY WERE IN THEIR APARTMENT WHILE USING THE DRUGS. THEN IN THE AFTERNOON THEY SWITCHED FROM USING METH TO CRACK COCAINE. THEY CONTINUED TO SMOKE CRACK UNTIL LATE IN THE EVENING. AFTER RUNNING OUT OF CRACK THEY SWITCHED TO SMOKING WEED AND DRINKING ALCOHOL.
